株式会社プロトクリエイティブ / Proto Creative Corporation

多様化する消費者ニーズに対応するためには、付加価値の高い情報誌の作成が必要不可欠であり、消費者の視点に立った高度な感性と技術を持った編集スタッフの育成を行っていく必要があると判断し、1991 年 2 月同社を設立いたしました。

High-value-added information newsletters are essential to meeting the diversified needs of consumers. Recognizing the importance of nurturing editing staff with high levels of sensibility and expertise from the consumer's perspective, we established Proto Creative Corporation in February 1991.

株式会社プロトール / Protol Corporation

Recognizing the need to enter the growing e-commerce business, we established MPEC Corporation in March 2000 as a joint venture with Mitsui & Co., Ltd. With a network of automobile dealers and consumers, MPEC provides online quotations and brokerage services, as well as integrated services related to automobile purchases.

株式会社リペアテック / REPAIR - TECH INC.

自動車車体修理業界とのつながりが深い同社をグループ企業とすることにより、当社の既存取引先である自動車販売 業界に対し、新たな商品・サービスの提供が可能となることと、自動車車体修理業界において新たな顧客層を獲得す ることが可能になるものと判断し、2002 年 10 月同社を子会社化いたしました。

REPAIR - TECH INC. is deeply involved in the automobile body repair industry. By making such a company part of the PROTO Group, we felt that we could offer new products and services to our existing customers in the automobile sales sector, while also attracting new customers from the automobile body repair industry. For this reason, we made REPAIR - TECH a consolidated subsidiary in October 2002.

(2004年8月26日:有限会社ビーボイドから株式会社マーズフラッグに組織変更)

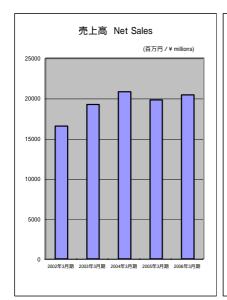

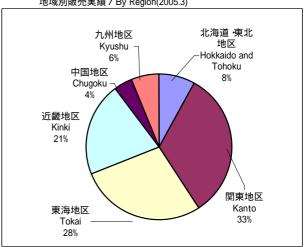
